Community Development Block Grant (CDBG) 24 CFR PART 570

SUMMARY

The City of Little Rock Department of Housing & Neighborhood Programs, Community Development Division is now accepting **only** CDBG Public Service Applications for the 2026 funding cycle.

OBJECTIVES

Funding projects and services that benefit low to moderate income people that are consistent with the Five-Year Consolidated Plan which identifies public service needs.

PLEASE NOTE

Only organizations with 501(c)(3) nonprofit status and a minimum of three (3) years' experience, and physically located in Pulaski County or local staff at the time of application for providing a CDBG eligible activity are qualified to apply.

If you are a startup organization or program, the City is unable to fund an activity until it shows viability and capacity. Activity should not be dependent solely on CDBG funding. Must have other funding sources and be financially stable without CDBG funding. Funds will be paid on a reimbursement basis upon submitting documentation of expenses eligibility.

Available funding for all nonprofit applications combined was roughly \$270,000 for program year 2025.

DO NOT SUBMIT APPLICATIONS THAT ARE OVER THE FUNDING AMOUNT. THE CITY WILL NOT FUND ANY MORE THAN IS AVAILABLE UNDER THE 2026 FUNDING CYCLE.

PLEASE BE ADVISED THAT PROJECTS SELECTED WILL BE SUBJECT TO FUNDING AVAILABILITY.

ELIGIBLE ACTIVITIES

The CDBG regulations allow the use of grant funds for a wide range of **public service activities** (24 CFR 570.201e), including, but not limited to: Employment services (e.g., job training); Crime prevention and public safety; Childcare; Youth services, Health services; Substance abuse services (e.g., counseling and treatment); Fair housing counseling; Education programs; Energy conservation; Services for senior citizens; Services for homeless persons.

HUD NATIONAL OBJECTIVES:

All activities funded through the Community Development Block Grant (CDBG) must demonstrate that the activity meets at least one of the following HUD CDBG national objectives (24 CFR 570.208):

- Activities benefiting low- and moderate-income persons;
- Activities which aid in the prevention or elimination of slums or blight; and
- Activities designed to meet community development needs having a particular urgency (referred to as urgent need).

PERFORMANCE MEASUREMENT:

HUD has implemented a mandated system of reporting performance measurements in a precise and timely manner. All the activities funded must identify one of the three performance measurements primary objectives and outcomes. Directly below are the primary objectives:

- Creating suitable living environment (in general, this objective relates to activities that are designed to benefit communities, families, or individuals by addressing issues in their living environment)
- Creating decent housing (this objective covers the wide range of housing activities that are generally undertaken with CDBG, HOME, or HOPWA funds)
- Creating economic opportunities (this objective applies to the types of activities related to economics)

There are three outcomes under each objective. They are:

- Availability/Accessibility applies to activities that make services, infrastructure, housing, or shelter available or accessible to low- and moderate-income people, including persons with disabilities. Accessibility does not refer only to physical barriers, but also to making the affordable basics of daily living available and accessible to low- and moderate-income people.
- Affordability applies to activities that provide affordability in a variety of ways in the lives of low- and moderate-income people. It can include the creation or maintenance of affordable housing, basic infrastructure hook-up, or services such as transportation or daycare.
- Sustainability applies to projects where the activity or activities are aimed at improving communities or neighborhoods, helping to make them livable or viable by providing benefits to persons or low- and moderate-income people or by removing or eliminating slums or blighted areas, through multiple activities or services that sustain communities or neighborhoods.

INCOME ELIGIBILITY CRITERIA

Funded activities must benefit persons whose annual income does not exceed 80 percent of the median income for the area, as determined by HUD. The current income limits are listed below, but limits are updated annually.

NOTICE OF PUBLIC MEETINGS AND FUNDING AVAILABILITY

Notice is hereby given that the City of Little Rock anticipates applying for three categories of funding from the U.S. Department of Housing and Urban Development for Fiscal Year 2026, Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME) funds, and Housing Opportunities for Persons with AIDS (HOPWA). The City will prepare a 2026-2030 Consolidated Plan and Fiscal Year 2026 Annual Action Plan.

In accordance with its Citizen Participation Plan, the City will conduct three community-wide public meetings to address housing and community development needs for the 2026-2030 Consolidated Plan and 2026 Annual Action Plan. The purpose of the meetings is to obtain the views and comments of individuals and organizations relative to the needs that may be addressed by CDBG, HOME, and HOPWA funds. With the announcement of Notice of Funding Availability (NOFA) under CDBG, the public meetings are also scheduled to give citizens an opportunity to provide suggestions for proposed projects that may be eligible for funding under 2026 CDBG Program.

If a non-profit organization plans to submit a request for a project, an application form with all required information must be completed.
