



1 “Section 4. Pursuant to Little Rock, Ark., Rev. Code (“LRC”) § 2-262(c), when a member  
2 of the Commission has missed more than 25% of all regular meetings in one (1) calendar  
3 year, the Commissioner is automatically removed from his or her position. If, prior to the  
4 next scheduled meeting of the City Board of Directors, the Commissioner submits in  
5 writing his or her desire to remain on the Commission, the City Board of Directors, by a  
6 majority vote, shall allow the member to continue to serve.”

7 **Section 2. Exemption Under LRC § 2-262(c).** The Board of Directors hereby approves the  
8 amended attendance policy set forth in Article III, Section 4 of the Commission’s Bylaws as the  
9 Commission’s own attendance policy pursuant to Little Rock, Ark., Rev. Code § 2-262(c). The Commission  
10 is hereby exempted from the provision of § 2-262(c) providing for automatic removal based upon missing  
11 more than three (3) consecutive regularly scheduled meetings, to the extent such provision is inconsistent  
12 with the Commission’s approved attendance policy.

13 **Section 3. Prior Bylaws Superseded.** All prior provisions of Article III, Section 4 of the  
14 Commission’s Bylaws inconsistent with the amendment approved herein are hereby superseded.

15 **Section 4. Exhibit A.** A copy of Article III, Section 4 reflecting the amendment in strikethrough  
16 format is attached hereto as Exhibit A and incorporated herein by reference.

17 **Section 5. Effective Date.** This Resolution shall be effective upon its adoption by the Board of  
18 Directors.

## EXHIBIT A

### **Article III, Section 4 of the Bylaws of the Little Rock Public Safety Commission** *(Strikethrough Reflects Deleted Language)*

**Section 4.** Pursuant to Little Rock, Ark., Rev. Code (“LRC”) § 2-262(c), when a member of the Commission has missed more than 25% of all regular meetings in one (1) calendar year, ~~or more than three (3) consecutive regularly scheduled meetings,~~ the Commissioner is automatically removed from his or her position. If, prior to the next scheduled meeting of the City Board of Directors, the Commissioner submits in writing his or her desire to remain on the Commission, the City Board of Directors, by a majority vote, shall allow the member to continue to serve.
