WHEREAS, the City's Information Technology department has a need to renew its annual software subscription and licensure for Adobe software products which are currently utilized by the City's departments to support business processes as the City's current contract expires on August 8, 2026; and,

WHEREAS, per the quote attached hereto as Exhibit A, the cost for renewal of the City's Adobe subscription software license through authorized reseller, CDW-G is Sixty-Six Thousand, Three Hundred Eighty-Nine and 44/100 Dollars (\$66,389.44), plus a ten 10% contingency if needed, for a total of Seventy-Three Thousand, Twenty-Eight Dollars (\$73,028.00).

Section 1. The City Manager is authorized to enter into a Contract with CDW-G in an amount not to exceed Seventy-Three Thousand, Twenty-Eight Dollars (\$73,028.00), including applicable taxes and fees and a ten (10) percent contingency if needed, for the cost to renew the City's Adobe subscription software license for a term of one (1)-year.

Section 3. *Severability.* In the event any title, section, paragraph, item, sentence, clause, phrase, or word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or adjudication shall not affect the remaining portions of the resolution which shall remain in full force and effect as if the portion so declared or adjudged invalid or unconstitutional were not originally a part of the resolution.

Section 4. Repealer. All laws, ordinances, resolutions, or parts of the same, that ~~the~~ inconsistent with provisions of this resolution, are hereby repealed to the extent of such inconsistency.
