WHEREAS, although, Custom Truck One Source, L.P. participates in the Sourcwell cooperative purchasing program, the vendor's direct dealer pricing was Five Thousand Twenty-Four and 97/100 Dollars (\$5,024.97) cheaper than cooperative contract pricing thus making this vendor the lowest, responsive, and responsible bidder; and,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY OF LITTLE ROCK, ARKANSAS;

Section 2. The City Manager is authorized to execute any necessary documents to ratify the acquisition of one (1) new 2026 Ford F-550 4X4 with Terex Forestry Aerial Bucket Lift from Custom Truck One

Source, L.P. dba Custom Truck & Equipment, LLC, in the amount of \$165,774.03, including applicable taxes and fees.

Section 3. Funds for this expenditure are available in Parks & Recreation Bond Fund Account No. 332459-72300-B45D017 and Fleet Replacement Fund Account No. 108609-72300-S60C638.

Section 4. Severability.
